Vandenberg Air Force Base CA Hold Harmless and Indemnification Agreement

THIS IS AN IMPORTANT LEGAL DOCUMENT. BY SIGNING IT, YOU WILL GIVE UP IMPORTANT LEGAL RIGHTS. READ THIS DOCUMENT CAREFULLY. DO NOT SIGN IT UNLESS YOU UNDERSTAND AND COMPLETELY AGREE WITH ITS TERMS.

I release, indemnify and hold the United States Government harmless from and against any and all claims, demands, suits, liability and injury, however caused, arising out of or in anyway related to my participation in the Vandenberg Air Force Base Car, Truck and Motorcycle Show and on the designated areas associated with Vandenberg Air Force Base in any way, including any and all claims, demands, suits, liability and injury caused or contributed to by the negligence of the United States Government. I am freely assuming the risk of any personal injury, death, property damage, loss or destruction that may result while participating in the above activity. There are inherent, known, possible and potentially unknown risks and hazards associated with the above activity. I will not hold the United States Government responsible for any injury, however caused, arising out of or in anyway related to the above activity, even if my injury is caused or contributed to by the negligence of the United States Government.

As used throughout this agreement, "I" includes, but is not limited to, my family members, my heirs, administrators, executors or assigns. "United States Government" includes, but is not limited to, Vandenberg Air Force Base (VAFB), the United States Air Force and any other United States Government agency or organization, including, but not limited to, officers, members, agents, or employees of VAFB, the United States Air Force and any other United States agency or organization. "Injury" includes, but is not limited to, personal injury and death, any financial loss and any property damage, loss or destruction that may result arising out of or in anyway related to my participation in the above activity in any way.

I may be held liable for any damages or loss to the United States Government which is caused by my negligence, gross negligence, willful misconduct, dishonesty or fraud. Invalidity or unenforceability of one or more provisions or parts of this Agreement shall not affect any other provision or part of this Agreement.
